
PROPOSED MODE OF COLLABORATION



1. EFFECTIVE DATES AND AMENDMENTS

- I. This MOU shall take effect upon signing by both parties and shall remain in effect for a period of Five (5) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.


1. The two Educational Institutions will:

- d) Conduct guest lectures by the faculties of both the colleges honorary for which no TA/DA will be charged by the faculty of both institutions.


